II. Approval of Minutes

The minutes for the March 21, 2019 meeting were approved as written.

III. Commission Updates (Updates pertinent to COPT mission)

General Membership

Dr. Sawyer: Dr. Sawyer will be conducting another CIT training in May in Bethlehem. Thirty-five state troopers will be trained with a goal of improving response to veteran crisis. She will also be on the Laura Noye NPR radio show talking about first responders.

Nick Tolentine: Nick is a nurse practitioner and in that role he was recently able to assist a homeless patient living in car and to connect to Easter Seals and leverage the resources that the Commission has helped to facilitate.

Mike Rice: The next SVAC meeting will be held on May 7th. Their last meeting had representatives from HUD and Harbor Home in attendance and dealt with homelessness issues. SVAC will continue to review legislative activity as bills move from the House to Senate. SVAC's Memorial Day ceremony will be held on May 30th at 11:00 am.

Erin Hall: Last month was brain injury awareness month. The BIA had a table at the VA.

Richard Osborne: As a member of the health and human services committee, Representative Osborne is dealing directly with legislation. As yet, he hasn't seen any bills that are strictly related to veterans.

Robert Motolla: Next month is mental health awareness and recovery month. Robert indicated that there will be a photography exhibit at the Dartmouth Hitchcock Medical Center in Lebanon. The nationally-traveling exhibit designed to reduce the stigma of mental illness titled "99 Faces," will be on display in Lebanon from April to September.

Ken Norton: NAMI is designated by the state to submit a federal SAMHSA grant. They are working with National Guard and North Country and expect to know by end of summer whether they win the grant.

Peggy LaBrecque: The Veterans Home is still looking for LNAs and nurses. They will be having their Memorial Day celebration on Tuesday May 28th. About 75 veterans will be attending and they enjoy visitors. The public is encouraged to attend. They recently conducted a Vietnam Veterans event which was very moving. Vietnam Vets are working to ensure no other vets are ever treated like they were.

Suellen Griffin: Suellen is retiring but has been encouraged that the CMHC liaison program has continued despite a lack of funding. Seven representatives still attend meetings. She hopes this will continue.

Catrina Watson: The Medical Society will be conducting their Family Physician Conference. Catrina encourages committee member who have anything they would like her to take to the conference to let her know.

NH DHHS Update

Amy Cook: Provided the Commission handouts on the Governor's Challenge that outlined the expectations of what results will look like along with a Progress Report. Four people represented NH in Washington DC at a suicide prevention related session. A variety of topics were discussed including programs around the country that might be candidates to implement in New Hampshire. A team will be returning to DC in May.

The liaison initiative has hit a funding snag. Funding is being requested through the National Guard. However, it might be delayed. The group plans to meet next month regardless of funding status.
