    - State is not planning to reopen testing
    - State is providing information to assist individuals in the process to do on their own
    - Doris Brock submits formal request to be presented by Karen Craver to HHS for testing to be reopened
    - HHS will provide formal response
  - 2. Amanda not in attendance, BEE shop will follow up
  - 3/5. William Gaudreau
    - Informational page of how-to's on submitting claims
      - New page will be added to website to assist veterans in process
        - Will include documents and links
          - Once running, VS will send link to workgroup
    - Sent out first informational bulletin
      - New Name of Cancer registry "Pease Health Concerns Contact List"

  - Looking for contacts for physician consultation
- 6. Karen Craver- Ask the Question
  - Ask the Question Campaign
  - Connected with Amy to provide information regarding campaign
  - May be able to provide input for site
  - Will try to get Amy XXX to attend next meeting
- 7. Maj Brindisi- baseline blood testing
  - Baseline blood testing at Pease
    - Testing already in place for some shops on Occupational Health Program
    - Possibly pursue Military Entrance Processing Station (MEPS) for blood testing prior to military service
    - What is the blood being used for and how long is it saved
  - LtC Piotrowski
    - What are we testing for?
    - What diseases are we looking to focus on?
      - Exposures and trending diseases affects the needed labs
  - Mindi Messner

- Mentions that some people were unaware of PFC testing
- Asks how people were notified of testing
- Outreach seemed to be insufficient
- Can there be a baseline for PFCs for workers on base
- Karla Armenti
  - Asks what lab testing is currently in place for occupational health
- Brindisi
  - List of labs drawn will be provided, MDG testing protocols
  - Will need to follow up with MEPS protocol

#### 8. Body burden testing

- Links sent in group email by Karla
- will resend to working group and OEHWG for review

#### 13. SSgt Davidson- Shipyard

- Communicating health concerns with Shipyard
  - Lot of turnover for navy yard providers
  - May be most beneficial to create comprehensive memo to place in electronic medical records for all members on base
  - Will need further follow up

#### Health Survey

- Doris Brock presents Health Survey
  - Summary data on 130 members who worked on Pease
  - o Independent survey
  - Regarding concerned retirees
  - Created by Mindi Messner about a year ago voluntary basis
- Maj Brindisi
  - Suggests forwarding data onto USAFSAM to assist with Pease study
  - Will send survey to Maj Paine for review on Friday for request submission
- Subcommittees
  - Maj Brindisi suggests committees
    - Communication Committee
      - Doris Brock volunteers to head
        - Gather contacts
        - Logistics to reach retirees
        - How to push information in an efficient and effective manner
        - Volunteers
          - Mindi Messner, William Gaudreau, Pamela Bapp
    - Patient Advocacy Committee
      - Gather information for provider pamphlet
      - Volunteers
        - Karla Armenti, Karen Craver, Doris Brock, LtC Piotrowski. Doris Brock
    - Suggestion for group interested in legislation
      - Not to be formal subcommittee
      - Information update group
      - CODEL will provide monthly update re: legislative actions
      - Maj Paine makes recommendations
        - Private entities that may be able to help push for legislation (i.e. retiree group)
        - Government/military pushing for policy change may cause issues down the line
          - Ensure those advocating for legislation should be individuals and private groups, not a military organization itself

- Continued Discussion regarding education outreach
  - Educating individuals to help them then speak with healthcare providers
    - May be helped by the Ask the Question campaign
    - o Doris Brock
      - This program may help people advocate for themselves
      - We still need to educate the providers
        - Providers must understand hazards, common diseases, important testing to be done
      - LtC Piotrowski
        - Important to establish specific information needed for
        - providers to understand to improve quality of care
      - Karen Craver
        - Ask the Question Campaign
          - Aimed at providers
          - Helps guide care

- Mindi Messner
  - Would members understand which chemicals they may have been exposed to throughout career
  - Chief Heiman
    - USAFSAM will be able to further breakdown substances of concern
  - Maj Brindisi
    - Request is not a standalone for provider information to diagnose patients
    - More information may be gathered by subcommittee for provider use
    - o Karla Armenti
      - Suggests using literature as foundation for creating provider information
- Other follow-up.
  - Need to find original communications re: PFOA exposure and testing and determine how, when and where communications to personnel
    - Add to Pease website
    - Add to Medical records
    - Add to patient advocacy material
    - Add to Veteran Services communications
- Doris Brock
  - Found 2018 article on common exposures on military bases- distributed at meeting (see attached)
  - Congressional Delegation Letter
    - o Update
      - Response from Secretary of Defense stating they had received letter
      - Plan to give comprehensive response by February 2019
- Chief Heiman
  - Proposes next meeting to take place at Pease Headquarters
